Introduction

The Present M.A. History syllabus is framed with the following main objectives;

- to acquaint the students with the recent development in History
- to make the students able to serve the current needs of the society
- to give the students specialized knowledge in definite areas like Nepalese History, Indian History, History of Far East, International History and Tourism.

The main features of the present syllabus are;

- International History is introduced as compulsory paper combining the Courses of European Diplomacy and History of Europe to impart the comprehensive knowledge of world affairs to the student.
- 2) The components of diplomacy are comprehensively included in International History and Diplomatic History of Nepal for the purpose of qualifying the students to join the Foreign Service.
- 3) Besides giving the knowledge of the International History and Far East, the History of South Asia is introduced in order to give the students the knowledge of the history of the SAARC region.
- 4) Considering the growing importance of tourism industry in Nepal a separate paper of Historical and Cultural Tourism is introduced.
- 5) Detailed and critical knowledge in the different aspect of Nepalese history from ancient to recent time.
- 6) Historiography and Research Methodology are developed as two separate papers to impart the in-depth theoretical and practical knowledge of history and its methodology.
- 7) In the Methodology course 20 marks have been allotted for field research paper on any historical or cultural place of the district where the campus is situated. The objective is to train the students in research methodology.
- 8) To train the students on archives and museums a separate course on archival science and museology has been included.

Eligibility Criteria

The students having passed the Bachelor-level Examination on any Faculty recognised by Tribhuvan University or the Shastri degree course with English as a subject are eligible for M. A. History.

Duration of the Course and Examinations

The duration of the course is of two years and there is a university examination at the end of each year. 70 per cent attendance in the class is compulsory. A student who has passed his/her two years of study will be graded on the basis of the two year's average marks as follows:

- 75 percent and above Distinction
- 60 percent and above First Division
- 50 percent and above Second Division
- 40 percent and above Third Division

Course Objectives:

The objective of this course is to make a critical analysis of the political development in Pakistan, Bangladesh, and Sri Lanka, since their independence, with socio-economic background wherever necessary. Special emphasis will be laid on the democratic and authoritarian regimes in Pakistan and Bangladesh and the role of the army in them, on the parliamentary and presidential rules in Sri Lanka and the ethnic conflicts, and on the relations of these countries with India.
